Please provide an overall state of play of your project: what are the achievements of the project at this stage? Are the initial project activities and objectives being carried out and reached so far?

At this stage first project activities have been implemented by Ethnic Culture Centre Suiti Foundation (ECC Suiti) as a lead partner in close cooperation with all project partners:

- Partnership agreements with all partners signed in October-November 2020 (7 partnership agreements);
- information about project and organised activities published in the partner's websites and media (Facebook, newspapers etc.);
- Kick-off project meeting organised(in November 2020);
- Second project meeting organised (in February 2021);
- First two days of virtual Short-term Joint Staff Training event in Latvia organised;
- Project dissemination plan developed;
- Joint Google drive account for all project documents and photos created.

However, due to the epidemiological global situation, all project meetings and training activities were organized virtually on the Zoom platform rather than in person, as originally planned. Also, taking into account the situation in the world, the project implementation period has been extended until August 31, 2023, as well activities re-planned. However, these changes do not jeopardize the successful implementation of the project and the achievement of its objectives. The partners have agreed to initially carry out the activities virtually and, when possible, to organize the events in person. All project partners actively involved in all project activities.

Please describe further in details the project activities supported by the grant for Project Management and Implementation that have been carried out until now.

Each organisation has created their local project management team, consisting of 1-2 persons in each organisation - highly experienced professionals in their field. Project management teams have been financed from the budget for project management and implementation. Project management teams are responsible for overall project management process - administrative process, financial organisation and reporting. ECC Suiti has signed Partnership agreements with all partners (7 partnership agreements in total) in which the partners agree on the implementation of the project - financing, responsibilities, rights, etc.

A project financing and dissemination plan as well as detailed project timetable has been developed and updated during 2 virtual Transnational project meetings (in November 2020 and in February 2021). Additionally partners have carried out other activities:

- Project dissemination activities (information in partner websites, Facebook, newspapers, TV (in Croatia);
- Creation of materials have been started the partners agreed on the scope, content and deadlines of the materials during the second project meeting;
- Project Google drive account created with all project materials.

How is the monitoring of the project being carried out so far and by whom?

Partners are reporting regularly to lead partner about their project activities carried out. Lead partner is mainly responsible for project monitoring in close cooperation with project partners. Self-evaluation of project activities and results reached so far have been provided through Evaluation questionnaires to monitor the project progress. After each Transnational project meeting and Short-term Joint staff training event participants filled Evaluation questionnaires and the results were summarized and analyzed by each project partner's management group, responsible for each event in order to give and idea of the quality of the activities. The analyze of the questionnaires shows that the events were organized very successfully - participants rated organised activities as excellent/good - emphasizing the quality of organizing activities in virtual environment.

How did the project partners contribute to the project so far? Has the distribution of tasks been adjusted since the application stage?

All partners contributed their part in implementation of project activities. They took part in two Transnational project meetings and two days of Short-term Joint staff training event, organised by Lead partner in Zoom in April 2021. They were actively involved in the planning of all activities and gave advices and suggestions concerning programmes of the events. All partners have organised project dissemination activities (information in partner websites, Facebook, newspapers, TV) They also took part in creation of project dissemination, finance plan and detailed timetable. Distribution of tasks hasn't been changed since the application stage.

9. Follow-up

9.1. Impact

What has been the project's impact so far on the participants, participating organisations, target groups and other relevant stakeholders?

The main impact of the project at this stage is on project partners and participants which participated in project events in Latvia (24, including local participants). They had opportunity to explore ICH safeguarding and promoting practises in these countries. 
